

C. Tax Forms and Income Information

All tax filers must submit a **SIGNED** copy of their 2007 Federal Income Tax returns (includes the 2007 IRS Form 1040, 1040A, 1040EZ, Telefile Tax Record, a tax return from Puerto Rico or a foreign income tax return).

If you did not keep a copy, you can call the IRS at 1-800-829-1040. Press 3 "For all other questions", and wait until the end when you can talk to a person and request a **transcript** of your year 2007 account.

Non filers: Complete the box for those people who did not file and are not required to file a 2007 Federal Income Tax Return. List below your employer(s) and any income received in 2007 (use W-2 forms or other earning statements). Answer "zero" if you did not earn any money in 2007.

\$	Any other untaxed income or benefits not reported elsewhere on Worksheets A and B, such as workers' compensation, untaxed portions of railroad retirement benefits, Black Lung Benefits, disability, etc. Don't include student aid, Workforce Investment Act educational benefits, or benefits from flexible spending arrangements, e.g., cafeteria plans.	\$
\$	Veterans' non-education benefits, such as Disability, Death Pension or Dependency & Indemnity Compensation (DIC) and/or VA Educational Work-Study Allowances.	\$

\$	Child support you paid because of divorce or separation or as a result of a legal requirement. Don't include support for children in your (or your parents') household, as reported in question 90 (or question 66 for parents)	\$
